The Hon'ble A. P. High Court by order dated 05.09.2013 in W.P. No. 26025/2013 has directed that the representation of the petitioners (to the effect that the parental lines of extant varieties notified under section 5 of Seeds Act, 1966 must be registered under the category of extant notified variety under section 5 of Seeds Act, 1966 in light of Ministry of Agriculture's OM No. 3-26/2013-SD.IV dated 04.06.2013 clarifying that under seeds Act, 1966 when hybrids are notified parental lines are deemed to be notified-Copy of OM enclosed) must be disposed of within six weeks from the date of receipt of copy of the order. Copy of the order was received by this office on 18.09.2013 and accordingly the same must be disposed of by 30.10.2013.
