PUBLIC NOTICE (6 of 2021)

Sub: Extension of Time Limit under PPV&FR Act, 2001 - Order dated 8th March, 2021 of Hon'ble Supreme Court of India in Suo Motu Writ Petition (Civil) No. 3 of 2020.

As per the order dated 8th March, 2021 of Hon'ble Supreme Court of India in Suo Motu Writ Petition (Civil) No. 3 of 2020, the period from 15.03.2020 till 14.03.2021 shall stand excluded while computing time limit. In case where the time limit set in a given matter of an application has expired during the period between 15.03.2020 to 14.03.2021, the same stands extended upto 90 days from 15.03.2021 and in those cases where the actual period for expiry of the limit is greater than 90 days, the same stands extended for the balance period as provided in the statutes.

Accordingly, based on the above-said order of the Hon'ble Supreme Court, the time limit for all the proceedings under the Act and Rules (other than time limit for registration of extant varieties in respect of which public notice No.5 of 2021 has been issued) would be as follows:-
